

# CONDITIONS OF PARTICIPATION

## WHO CAN PARTICIPATE?

- You must be able to safely climb and work on ropes.
- You must be at least 18 years old.
- You confirm that your health condition allows you to safely participate and that you are responsible for any and all injuries that are caused due to a misjudgement of your health condition.
- You can either use your own equipment or loan a set from Skyproff. We can only offer our equipment to a limited number of participants. If you use Skyproff's equipment, you must return it in exactly the same condition as you got it.
- You are obligated to wear the competition T-shirt during the whole event (it is included in the participation fee).
- You are obligated to represent Skyproff, the Estonian rope access community and the field of rope access in general in the best possible light during the whole event (being polite, acting according to safety regulations, using rope access best practices).
- You agree that you will be photographed and/or filmed during the event and these materials may be used in Skyproff's social media accounts or in other media channels with the goal of covering/introducing the Skyproff Cup event, rope access in general etc to the wider public.

## PARTICIPATION FEE

- The participation fee is 30 euros per participant (until February 14th: 20 euros)
- For the participation fee you will receive:
  - the right to participate in the Skyproff Cup competition;
  - a high-quality sports shirt;
  - free drinks and food on location.
- You must pay the participation fee to Skyproff OÜ bank account latest on the day before the event (LHV bank IBAN account EE427700771001037987) or pay it in cash on the same day before the competition.
- The participation fee is non-refundable, except if Skyproff decides to cancel the event.

## REGISTRATION/CANCELING

- Each competitor must register themselves to the competition.
- The final stage of registration is paying the participation fee. You will be guaranteed a place in the competition only if you have registered and paid the participation fee.
- If you have already registered but decide to decline the event, you must notify Skyproff at least 3 weekdays in advance ([skyproff@skyproff.ee](mailto:skyproff@skyproff.ee) or via phone +372 58502424). Then you will get a refund for your participation fee.
- If you cancel 2 weekdays before the event, you will get a refund of 50% from the participation fee.

- If you cancel 0-1 weekdays before the event, you will not get a refund from the participation fee.

#### TRAINING DAYS

- We are organising training days before the competition for all the competitors
- During the training day competitors can practice 8 exercises of which some are in the competition
- One time training day ticket costs 10€
- When you register for all 3 training days and pay upfront, you'll get them with the cost 25€

#### RIGHTS AND OBLIGATIONS OF THE ORGANIZER

- Skyproff OÜ reserves the right to change the timetable, prize fund etc of the event.
- Skyproff OÜ reserves the right to cover the event and its participants in its social media accounts and other channels to promote the image of working at height, using rope access and Skyproff OÜ.
- Skyproff OÜ reserves the right to remove a participant/viewer from the event in cases of rude behaviour, disturbing other participants, damaging the property of Skyproff or other parties, using unsafe equipment or practices in the competition or if the organizer of the competition decides that the participant's health condition is not good enough to compete safely.
- Skyproff OÜ is obliged to ensure safety and professionalism during the event within reasonable means.
- Skyproff OÜ is obliged to evaluate the competition fairly and objectively, based on IRATA official guidelines, rope access best practices, safety rules for working at height and other applicable guidelines.
